Did some additional research and spoke to Jones Day about PA. PA laws on this are very stringent.

The fine can be up to \$25K and it can be prosecuted as a criminal misdemeanor. Also, attorneys who are engaged in lobbying (including as legal advisors to unregistered lobbyists) can be referred to relevant disciplinary committees.

Given that fact, if we are going to move forward with this kind of activity in PA, I cannot advise further on it.

The administrative body can fine a relatively small amount. But the matter can be referred to the state AG for further investigation and prosecution (not sure if it's a civil violation or a criminal matter) - in any event, that's where the real costs would come into play.

I'm not an expert in this area and we'd need outside counsel to advise us. I can ask Jones Day to look more closely at the PA laws if you'd like.
